- 1. Property: I understand that the use of Academy provided technology is a privilege, not a right. I understand that Academy provided technology equipment, including, but not limited to, Computers, Chrome books, iPads, etc., (including chargers and protective cases) are provided for use during the length of enrollment. Such equipment shall remain the property of the Academy.

I understand that the following policies apply to the use of all Academy issued technology whether inside or outside the Academy premises. All technology equipment is provided for educational purposes only, and is to be used in accordance with Use Agreements and Academy procedures and policies, including the student code of conduct, found in the Student Handbook.

- 2. Return of equipment: I agree to return all Academy provided technology equipment at the end of the school year, upon withdrawal from the Academy, or at the time requested. All technology equipment must be returned and checked in by an Administrator. If equipment is not returned I understand I will be responsible for the replacement cost of the equipment.

- 3. Personal Responsibility: I understand that I am responsible for my use of the provided technology equipment. I understand that I will be held personally responsible for damage or loss caused by abuse or negligence as determined by the Academy Administration. I understand that I will be responsible for full replacement costs if the technology equipment is damaged or lost. If there is an insurance claim on the equipment, the student and/or advocate are responsible for up to a \$280 deductible per incident.

I agree to report incidences of theft or damage to the Academy Administration within twenty-four (24) hours of receiving knowledge of the loss.

I also understand that my communications over the Internet and through email may be traceable back to this Academy or to me. I will always use the provided technology equipment in accordance with the terms of the Use Agreement and Academy guidelines.

I understand that my privilege to use Academy provided technology equipment may be revoked, suspended, or limited at any time for any violation of this Agreement, or any other violation of the Academy's policies, student code of conduct or federal, state, or local laws. The Academy will be the sole arbiter of what constitutes a violation.

- 4. Release: I release and agree to hold the Academy, and all other sponsoring organizations related to the Internet connection, from any and all liability foreseeable or unforeseeable for damages or injury resulting directly or indirectly from the use of the provided technology equipment.

I also agree to defend, indemnify, and hold harmless the Academy, its Board members, staff and agents from and against any such claims, demands, suits, damages, liability, costs, and expenses (including reasonable attorney fees) incurred as a consequence either directly or indirectly of the granting of this agreement.

I have reviewed, understand, and agree to abide by the Technology Equipment Use Agreement.
